EXTRACT OF MINUTES of a regular public meeting of the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, held in the Board Room at Frederick T. Owens Village Hall, 14700 South Ravinia Avenue, in said Village, at 7:00 p.m., on the 21<sup>st</sup> day of July, 2025.

The President called the meeting to order and directed that the roll be called. Upon the roll being called, the following Trustees were physically present at said location: The following Trustees attended the meeting by video or audio conference: No Trustee was not permitted to attend the meeting by video or audio conference. The following Trustees were absent and did not participate in the meeting in any manner: The President announced that the Village has developed a list of capital projects for which it reasonably expects to reimburse itself for the expenditures related thereto with the proceeds of one or more obligations and that the President and Board of Trustees would consider the adoption of a resolution expressing the Village's official intent to reimburse itself for such expenditures. Whereupon Trustee \_\_\_\_\_ presented and the Village Clerk read by title a resolution as follows, a copy of which was provided to each Trustee prior to said meeting and to everyone in attendance at said meeting who requested a copy:

RESOLUTION expressing official intent regarding certain capital expenditures to be reimbursed from proceeds of one or more obligations to be issued by the Village of Orland Park, Cook and Will Counties, Illinois.

WHEREAS, on December 4, 2023, the President and Board of Trustees (the "Board") of the Village of Orland Park, Cook and Will Counties, Illinois (the "Village"), adopted a resolution (the "Prior Resolution") expressing its official intent to reimburse the Village for certain capital expenditures relating to the capital projects described therein with the proceeds of obligations of the Village in the maximum principal amount of \$7,800,000; and

WHEREAS, all or a portion of the expenditures (the "*Prior Resolution Expenditures*") relating to such capital projects (i) were paid within the 60 days prior to the passage of the Prior Resolution, or (ii) have been or will be paid on or after the passage of the Prior Resolution; and

WHEREAS, the Village reasonably expected to reimburse itself for such Prior Resolution Expenditures with the proceeds of one or more its obligations, subject, however, to the maximum amount of obligations of \$7,800,000 as set forth in the Prior Resolution; and

WHEREAS, the Board now desires to express its additional official intent to reimburse the Village for the list of capital projects developed by the Board and described in *Exhibit A* hereto (collectively, the "*Projects*"); and

WHEREAS, all or a portion of the expenditures relating to the Projects (the "2025 Resolution Expenditures") (i) have been paid within the 60 days prior to the passage of this Resolution, or (ii) will be paid on or after the passage of this Resolution; and

WHEREAS, the Village reasonably expects to reimburse itself for the 2025 Resolution Expenditures with the proceeds of one or more its obligations:

Now, Therefore, Be It and It Is Hereby Resolved by the President and Board of Trustees of the Village of Orland Park, Cook and Will Counties, Illinois, as follows:

- Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.
- Section 2. Intent to Reimburse. The Village reasonably expects to reimburse the 2025 Resolution Expenditures with proceeds of one or more series of its general obligation bonds or other obligations of the Village (in any event, the "Bonds").
- Section 3. Maximum Amount. The maximum aggregate principal amount of the Bonds expected to be issued to reimburse the costs of the Projects paid prior to their issuance and to complete the Projects is \$40,000,000, not including the costs of issuance of the Bonds.
- Section 4. Separate Action Required to Pursue Projects and Expend Funds. This Resolution does not and shall not be construed to obligate the Village in any manner to pursue any identified Project or expend any funds for the completion of any identified Project, and the Board shall retain full discretion to approve such Project and any expenditure of funds relating thereto, and such approval shall be by separate action of the Board.
- Section 5. Ratification. All actions of the officers, agents and employees of the Village that are in conformity with the purposes and intent of this Resolution, whether taken before or after the adoption hereof, are hereby ratified, confirmed and approved.
- Section 6. Authorization. This Resolution is made pursuant to Treasury Regulations Section 1.150-2. The Village intends this Resolution to satisfy the requirements of the Internal Revenue Code of 1986, as amended, and the regulations promulgated thereunder, and specifically Treasury Regulation Section 1.150-2(d), regarding the declaration by the Village of its official intent to issue its Bonds for the purpose of reimbursing original expenditures (as that term is

defined in Treasury Regulations Section 1.150-2(c)) incurred with respect to the Project within 60 days preceding the adoption of this Resolution.

Section 7. Severability. If any section, paragraph or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this Resolution.

Section 8. Repeal. All resolutions or parts thereof in conflict herewith be and the same are hereby repealed and this Resolution shall be in full force and effect forthwith upon its adoption.
