# ADDENDUM B to Municipal Payroll Services

#### Dated March 27, 2020

#### Amended September 10, 2021

#### Between

The Village of Orland Park, Illinois ("VILLAGE") and Lauterbach & Amen, LLP ("CONTRACTOR")

WHEREAS, on March 27, 2021, a certain Agreement regarding Municipal Payroll Services between the Village and the Contractor was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on September 10, 2021, a certain Agreement regarding Municipal Payroll Services between the Village and the Contractor was amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, on April 4, 2022, a certain Agreement regarding Municipal Payroll Services between the Village and the Contractor was amended (hereinafter referred to as the "Addendum B"); and

WHEREAS, the Village wishes to modify SCOPE OF WORK AND PAYMENT.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

- 1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
- 2. <u>SECTION 1: THE CONTRACT DOCUMENTS</u> of said Agreement shall be amended to include Addendum B dated April 4, 2022: and "Engagement Letter dated March 1, 2022"
- SECTION 2: SCOPE OF THE WORK AND PAYMENT of said Agreement shall be amended to include Accounting Analyst Services billed at a monthly rate of \$11,500, beginning April 1, 2022 through March 31, 2023. The fees will then increase 3.0% in each subsequent year, unless there is a change in the services provided.
- 4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
- 5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the 4 day of April, 2022, amended the 10 day of September, 2021, shall be attached to and form a part of the Agreement dated the 27 day of March, 2020, and shall take effect upon signature below by duly authorized agents of both parties.
