- 1. In the event of any conflict or inconsistency between the provisions of this Addendum and the Agreement, the provisions of this Addendum shall control.
- SECTION 1: THE CONTRACT DOCUMENTS of said Agreement shall be amended to include Addendum B dated April 7, 2022.
- 3. <u>SECTION 4: TERM OF THE CONTRACT</u> of said Agreement shall be amended to strike the completion deadline, April 29, 2022 and include a new completion deadline of July 29, 2022.
- 4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
- 5. This Addendum may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum, made and entered into effective the 8 day of April, 2022, amended the 20 day of December, 2021, shall be attached to and form a part of the Agreement dated the 24 day of September, 2021 and shall take effect upon signature below by duly authorized agents of both parties.
