ADDENDUM A TO 2023 PAVEMENT MARKING, DATED MAY 8, 2023, BETWEEN THE VILLAGE OF ORLAND PARK AND ROADSAFE TRAFFIC SYSTEMS, INC.

- 4. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
- 5. This Addendum A may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum A, made and entered into effective the 25th day of October, 2023, shall be attached to and form a part of the Agreement dated the 8th day of May, 2023, and shall take effect upon signature below by duly authorized agents of both parties.
