



**ADDENDUM A TO ORLAND HILLS EAST DESIGN, DATED JULY 17, 2023, AMENDED  
FEBRUARY 1, 2024,  
BETWEEN  
THE VILLAGE OF ORLAND PARK AND V3 COMPANIES OF ILLINOIS LTD**

WHEREAS, on July 17, 2023, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as “Village”) and V3 Companies Of Illinois Ltd (hereinafter referred to as “Consultant”) for the performance of certain professional services for the Village in connection with Orland Hills East Design (hereinafter referred to as the “Project”, the “Work”, or the “Services”) was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on February 1, 2024, a certain Agreement between the Village and the Consultant for the Project/Work/Services was previously amended (hereinafter referred to as the "Addendum A"); and

WHEREAS, the Village wishes to enter into an Agreement incorporating the Terms and Conditions of the contract dated July 17, 2023 and amend the **SCOPE OF WORK, COMPENSATION, CONTRACT DOCUMENTS and TERM OF THE CONTRACT**.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum B and the Agreement, the provisions of this Addendum B shall control.
2. **SECTION 1: SCOPE OF THE WORK** of said Agreement shall be amended to include the “Scope of Work” as set forth in Consultant’s Proposal, dated February 19, 2024.
3. **SECTION 2A: COMPENSATION** in said Agreement shall be amended to strike “not-to-exceed amount of \$98,244.00”; increase contract by a “not-to-exceed amount of \$27,300.00” and replace with a new total “not-to-exceed amount of \$125,544.00”.
4. **SECTION 3: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum B, dated March 4, 2024.
5. **SECTION 4A: TERM OF THE CONTRACT** of said Agreement shall be amended to strike the revised completion date of March 1, 2024, and replace with an amended completion date of August 1, 2024.
6. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
7. This Addendum B may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum B, made and entered into effective the **4<sup>th</sup> day of March, 2024**, shall be attached to and form a part of the Agreement dated the 17th day of July, 2023, amended February 1, 2024, and shall take effect upon signature below by duly authorized agents of both parties.

IN WITNESS WHEREOF, the parties have caused this Addendum B to be executed by their duly authorized officer in quadruplicate counterparts, each of which shall be considered as an original.
