



**ADDENDUM B AUTOMATIC VEHICLE LOCATOR, DATED NOVEMBER 15, 2021,
AMENDED JULY 5, 2022;
BETWEEN
THE VILLAGE OF ORLAND PARK AND SAMARA, INC.**

WHEREAS, on November 15, 2021, a certain Agreement between the VILLAGE OF ORLAND PARK (hereinafter referred to as "Village") and Samara, Inc. (hereinafter referred to as "Contractor") for the performance of certain professional services for the Village in connection with Automatic Vehicle Locator (hereinafter referred to as the "Project", the "Work", or the "Services") was executed (hereinafter referred to as the "Agreement"); and,

WHEREAS, on July 5, 2022, a certain Agreement between the Village and the Contractor for the Project/Work/Services was previously amended (hereinafter referred to as the "Addendum B"); and

WHEREAS, the Village wishes to modify PAYMENT and CONTRACT DOCUMENTS.

NOW, THEREFORE, for and in consideration of the foregoing and the mutual covenants herein contained, it is agreed by and between the parties hereto as follows:

1. In the event of any conflict or inconsistency between the provisions of this Addendum B and the Agreement, the provisions of this Addendum B shall control.
2. **SECTION 1: SCOPE OF THE WORK** of said Agreement shall be amended to include the "Scope of Work" as set forth in Contractor's Proposals, dated March 18, 2023, and December 30, 2023.
3. **SECTION 2: COMPENSATION** in said Agreement shall be amended to add the words

"An additional ten (10) units and four (4) cameras at a cost of \$5,398.30 for FY2022, \$5,398.30 for FY2023, and \$5,398.30 for FY2024"
4. **SECTION 4: THE CONTRACT DOCUMENTS** of said Agreement shall be amended to include Addendum B, dated March 18, 2024: and "Proposals for Work, dated March 18, 2023, and December 30, 2023"
5. All of the other terms, covenants, representations and conditions of said Agreement not deleted or amended herein shall remain in full force and effect during the effective term of said Agreement.
6. This Addendum B may be executed in two or more counterparts, each of which taken together, shall constitute one and the same instrument.

This Addendum B, made and entered into effective the **18th day of March, 2024**, shall be attached to and form a part of the Agreement dated the 15th day of November, 2021, amended July 5, 2022, and shall take effect upon signature below by duly authorized agents of both parties.
